Advisory Radio Stations

To improve communication and enhance the 99.5 or 100.3 for additional emergency safety of those living, working and visiting in Ocean City, the Town of Ocean City has installed a FM emergency advisory radio system. WPSB **99.5 FM** is broadcast from the 65th Street Public announcements on this safety station: Safety Radio Tower and can be received in the greater Ocean City area. WWOP 100.3 FM also broadcasts the same programming from a tower near Ocean Pines and can be heard as you approach or depart the Ocean City area.

The primary use of this station is to inform the public of emergency conditions in the area and how to respond to them. An emergency could consist of severe weather or any other condition that could affect the well-being of the public in the Ocean City area.

This non-commercial radio station is managed by the Emergency Services Department, and in non-emergency situations, the station broadcasts community information 24 hours a day, seven days a week. Messages that play on a 10 to 15 minute cycle include emergency preparedness information. Having a noncommercial FCC license does not allow any commercial broadcasting.

The FM radio system was acquired by the Town with a Homeland Security grant.

News: Texas & Missouri

Check out this sentence from CBS and what the governor of Missouri said,

"Torrential downpours have swollen the Mississippi River, which could reach about 13 feet above its flood stage in St. Louis. Flooding could affect about 18 million people in states living along the river, from Minnesota to Louisiana.

In Missouri, flooding is blamed for at least 13 deaths -- 12 of which the governor called 'preventable' -- and is forcing mandatory evacuations."

Here's a description about what happened in Texas..

"A tornado that blew through Garland, Texas, killing eight people Saturday night has been classified as an EF4, with winds up to 200 mph.

It was one of two confirmed tornadoes that tore through North Texas in a storm that killed I I people, including an infant. The National Weather Service confirmed that the tornado that touched ground in Rowlett was an EF3."

Maryland is a pretty benign state as far as natural disasters go. We are lucky! Sometimes I think that it is just a matter of time until something significant happens here.

CPR is as easy as




Compressions
Push hard and fast
on the center of
the victim's chest

Airway
Tilt the victim's head Give mouth-to-mouth back and lift the chin to open the airway

Early chest compression can immediately circulate oxygen that is still in the bloodstream. By changing the sequence, chest compressions are initiated sooner and the delay in ventilation should be minimal.

2010 International Consensus on Cardiopulmonary Resuscitation and Emergency Cardiovascular Care Science With Treatment Recommendations

- I. Tap and shout "are you OK?"
- 2. Yell for help and get someone to call 911.
- 3. Look to see if any breathing or gasping.
- 4. Push hard and fast, give 30 compressions.
- 5. Open the airway and give 2 breaths.
- 6. Repeat sets of 30 compressions and 2 breaths.
- 7. Hands only CPR IS acceptable!!!!!!
