

**WORCESTER COUNTY ELECTRICAL BOARD
MEETING MINUTES
May 14, 2019**

The Worcester County Electrical Board met on Tuesday May 14, 2019 in the meeting room of the Isle of Wight County Office Building, 13070 St. Martin's Neck Road, Bishopville, Maryland. Members present were Chairman Kenneth Lambertson, Roy Case, Steve Kolarik, Michael Patchett and Duane Duncan Members. Also in attendance were Deborah Mooney, License Permit Clerk II and Maureen Howarth, County Attorney and Ed Tudor Director of Development, Review and Permitting.

The meeting was called to order by Kenneth Lambertson, Chairman, at 3:00P.M.

The minutes of the last meeting held on April 9, 2019 and the agenda for this meeting were reviewed. A motion was made by Michael Patchett and Roy Case seconded the motion, and unanimously carried to approve the minutes, as presented.

The following is the Treasurer's Report to be included in the minutes:

The Treasurer's Report for April: the Department issued (69) electrical permits, total revenue collected for electrical permits was \$1725.00, and \$420.00 for electrical licenses and 2 exams. There were (5) new master electricians Ryan Carrion, David Mosley, Jerome Monticquee, Jacob Young and Allen Calp all of them reciprocated with the State of Maryland, (2) new electrician general Lamont Roberts who reciprocated with Wicomico County and Eric Johnson who passed the exam. Jerome Lindinsky who passed the inspector's exam for Middle Department Inspection Agency and William Snyder unshelved his electrician limited licenses to be active again. Total for April is \$2145.00.

The first item of new business, the Board reviewed the application for Andrew Queen to take the Electrician's General exam in October. After reviewing the request Mike Patchett motioned to approve the application and Duane Duncan seconded the motion, and unanimously carried to approve the request.

The second item of new business the Board reviewed the application for Lloyd London for an electrician limited license. The license would cover low voltage security alarm systems. After reviewing the request Steve Kolarik motioned to approve the request and Mike Patchett seconded the motion, and unanimously carried to approve the request.

Thirdly, the Board reviewed the application for Michael Calloway for an electrician limited license. The license would cover low voltage security alarm systems. After reviewing the request Mike Patchett motioned to approve the request and Roy Case seconded the motion, and unanimously carried to approve the request.

Additionally, under new business Mr. Tudor had a question for the board members concerning horizontal boring under county roads. Apparently some of the contractors doing horizontal boring for DP&L were not obtaining permits from the department of county roads, boring at least 42" deep, or 10' past the edges of the roadway. It was recommended by the board members, that a letter be issued to the local boring contractors, making them aware of the requirements for boring under the county roadways and the necessity of obtaining permits.

There being no further new business Steve Kolarik motioned to adjourn the meeting and Roy Case seconded the motion. The vote was unanimous and the meeting was adjourned at 3:25 PM.
