This Addendum consists of two (2) pages, the revised Specification Section 004100 - Bid Form, and the revised Specification Section 012200 - Unit Prices.

CHANGES TO SPECIFICATIONS:

- 1. Specification Section 004100 Bid Form
 - A. <u>Replace</u> with enclosed Section 004100 Bid Form, which reflects an additional unit price for roof patching as an additional unit price.
- 2. Specification Section 012200 Unit Prices
 - A. Replace with enclosed Section 012200 Unit Prices, which reflects the addition of roof patching.

QUESTIONS AND ANSWERS:

1. Question: Regarding Addendum #5, Drawing A3.4, Detail F1, do we know how many LNFT we need to cover?

Response: The estimated linear feet is approximately 480 feet. The estimated quantity of conduit support brackets to be fabricated and installed for bidding purposes shall be eighty (80) based on installing the brackets 6 feet on center.

2. Question: Addendum 4, page 2, response to question 4 states, "Contractor shall provide unit price per square foot for patching". The bid form will need to be revised, but also did you want us to allow a certain square footage of patching in our bid?

PART 1 - GENERAL

1.1 RELATED DOCUMENTS

A. Drawings and general provisions of the Contract, including General and Supplementary Conditions and other Division 01 Specification Sections, apply to this Section.

1.2 SUMMARY

A. Section includes administrative and procedural requirements for unit prices.

B. Related Requirements:

- 1. Section 012100 "Allowances" for procedures for using unit prices to adjust quantity allowances.
- 2. Section 012600 "Contract Modification Procedures" for procedures for submitting and handling Change Orders.
- 3. Section 014000 "Quality Requirements" for field testing by an independent testing agency.

1.3 DEFINITIONS

A. Unit price is an amount incorporated into the Agreement, applicable during the duration of the Work as a price per unit of measurement for materials, equipment, or services, or a portion of the Work, added to or deducted from the Contract Sum by appropriate modification, if the scope of Work or estimated quantities of Work required by the Contract Documents are increased or decreased.

1.4 PROCEDURES

- A. Unit prices include all necessary material, plus cost for delivery, installation, insurance, applicable taxes, overhead, and profit.
- B. Measurement and Payment: See individual Specification Sections for work that requires establishment of unit prices. Methods of measurement and payment for unit prices are specified in those Sections.
- C. Owner reserves the right to reject Contractor's measurement of work-in-place that involves use of established unit prices and to have this work measured, at Owner's expense, by an independent surveyor acceptable to Contractor.
- D. List of Unit Prices: A schedule of unit prices is included in Part 3. Specification Sections referenced in the Part 3 "Schedule of Unit Prices" Article contain requirements for materials described under each unit price.

- E. Quantities stated for unit prices are estimates for the purpose of equitable bidding and establishing an estimated quantity of work. The Owner reserves the right to increase or decrease quantities. The requested unit prices will be used to adjust the Contract Sum to reflect actual quantities.
- F. Where quantities are indicated, Bidder shall calculate value for the unit prices on the Bid Form and include total cost in the Base Bid. At project closeout, unused quantities of unit prices shall be credit to the Owner by change order.

- 2. Unit of Measurement: Each lighting fixture including all accessories.

B. <u>Unit Price No. 2: Type B-1 Lighting Fixture Replacement</u>

- 1. Description: Remove and replace lighting fixture type B-1. Remove existing lighting fixture and install new lighting fixture, including conduit, supports, wiring, and lighting controls in accordance with Division 26 Specification Section 265119, "LED Interior Lighting".
- 2. Unit of Measurement: Each lighting fixture including all accessories.

C. Unit Price No. 3: Type C-1 Lighting Fixture Replacement

- 1. Description: Remove and replace lighting fixture type C-1. Remove existing lighting fixture and install new lighting fixture, including conduit, supports, wiring, and lighting controls in accordance with Division 26 Specification Section 265119, "LED Interior Lighting".
- 2. Unit of Measurement: Each lighting fixture including all accessories.

D. Unit Price No. 4: Type C-2 Lighting Fixture Replacement
