Hearing Minutes: The licensee and their attorney Hugh Cropper, Esquire, appeared before the Board with a Class "B" B/W/L 7 Day License request to expand licensed premises. The licensee was sworn in. Mr. Cropper introduced himself and stated he is representing Seven Star Hospitality of OC, LLC, Peter Elias is the managing member of the license today. Elias stated to the Board we were offered the opportunity to lease the space adjacent to Sand & Cedar Taverna stating this space will be used primarily for dining. Cropper instructed Elias to explain to the Board the progress that has been made at the licensed property. April Payne submitted to the Board another set of photos that Skip Cook had taken on August 20th showing the property's progress. Elias explained to the Board using the overhead photos, the construction of the brick columns are complete along with a couple of the arches inside the building, now that the brick columns are done the larger brick arches and walls can begin construction. Cropper stated the requested expansion will focus on dining space only; there won't be a kitchen facility in this expanded area. Elias stated "Correct." Mr. Coates submitted (Applicant's Collective Exhibit #1) letter from Hugh Cropper and floor plans. Commissioner Esham asked Cropper is this property being purchased or is it a lease. Payne stated to Cropper she has the lease for the existing property but does not have the lease for this property. Cropper stated he will get her a copy of the new lease. Commissioner Nichols asked Elias the additional space is about 900 sq ft. Elias stated "Yes." Elias emphasized the need for this additional area is from the standpoint that each seat is money that is important to the business plan and creating a world-class experience for the customers. Commissioner Nichols asked Elias you paid to have all the bricks displayed laid. Elias stated "Yes," it is thirty-five thousand (35K), noting the structural engineers have signed off on the work to complete the brick arches. Commissioner Nichols asked when you are looking to open this establishment. Elias replied late October early November 2024. Elias stated that once the building construction is complete, there will be a great deal of time spent in training staff, and food excellence. Elias stated this will take time "It needs to be perfect for the customers." Commissioner Nichols asked how much this establishment is forecasted to cost. Elias

stated we first thought \$1.0 million, but he believes it will be about two hundred thousand (\$200K) over budget. Commissioner Esham asked how long the lease is and who is financing this business. Elias stated the lease is a twenty (20) year lease, the financing is myself and my partner Karamjeet Singh (Ricky) who is my silent partner. Commissioner Esham asked so you stating there are no other partners. Elias stated "No," but we will be getting funding from friends or family, but they are not partners, most of the lease, loans or personal finance. Commissioner Esham asked for clarification regarding funding from other people. Elias stated to the Board when he was starting the Spain establishment if more funding was needed, I had support from family and friends. Cropper asked Elias this funding is an Arm's length interest promissory note. Elias stated "Yes." Commissioner Nichols asked these people are not partners. Elias stated "No." Commissioner Esham asked is the new lease the same as existing lease. Cropper stated this is new lease is four (4) five (5) year renewals for, fifteen thousand (\$15K) a year. Commissioner Nichols stated you believe you are going to spend about \$1.2 million and the funding comes from outside investors. Elias stated there is a personal loan along with myself investing my own money. Cropper stated to Elias under oath and for the record, it is your testimony that no other parties have a financial interest in this license expect for Seven Star Hospitality of OC, LLC which is yourself and Karamjeet Singh (Ricky). Elias replied "Yes." Commissioner Esham stated that if the establishment can't be open in the next five (5) months they will need to come back for an additional extension. The Board approved Sand and Cedar Taverna Class "B" B/W/L 7 Day License request to expand licensed

premises.

Cropper asked Elias is it correct that yourself, and along with Karamjeet Singh, and Sal Ramadan have a contract to purchase this property. Elias stated "Yes." Cropper asked Elias this property will be purchased under a real estate holding company and Seven Star Hospitality of OC, LLC will lease the property. Elias stated "Correct." Cropper stated this lease will be an Arms's length rate with a fixed rent. Elias stated "Correct." Commissioner Esham asked at this you have a lease have a lease agreement with the Rosenblit Family LLC. Elias stated "Yes," this lease was written with the option to purchase, and this is what I'm working on now. Commissioner Nichols stated that it sounds like there have been several changes since the license was approved this Board will need updated architectural plans once finalized to see what has changed. Elias stated once the plans are complete, he looks forward to sharing with the Board. Commissioner Nichols asked will this be similar funding arrangement as your other establishments. Elias stated for this project we are looking for funding for both construction cost and purchasing of the property, we have about \$1.5 million now and for the additional funding we are working with a local bank. Commissioner Esham asked Elias at this time you don't have the funding from the bank. Elias stated "Correct," we have other options at this time we are seeking the funds this way I feel it's promising we should know in a couple weeks, if all goes well with the bank, we should close the in September. Commissioner Nichols stated you are working to get this sale under contract. Elias stated we already have a purchase agreement with the Rosenblit Family to

Commissioner Nichols stated to Kumar, you understand you are under oath so it's your testimony that Kumal was only a cashier during working hours at Marlin Market. Karmar stated "Correct," once he was trained, he was only working as a cashier at Marlin Market.

The Board found that the violation did occur on April 22, 2024, and imposed \$2,000 fine is to be paid by certified check or cash by Friday, August 23, 2024, by noon and if not paid the license would be suspended until the fine was paid in full
