By COB this Friday, April 12, 2024 EA will package the submittal (initially provided for MDE construction permit application) to MDE Dam Safety along with a justification letter for the components discussed with MDE (i.e. retaining wall material, drainage area calculation, etc.)

Belt filter press design Geotech firm is ready to begin soil borings, consultant obtaining wetland clarifications from Dept. of Environmental Programs, scheduling site visit for wastewater operators to view candidate for equipment selection and discuss with that plant's operators their views on the equipment.
